## Stanislaus Farm Supply Terms and Conditions of Sale

Upon approval of credit, I (we) agree to pay in full and in accordance with the terms of sale as indicated on invoices of Stanislaus Farm Supply and as contained herein.

I (we) understand that payment of all invoices due must be received on or before the 25th of the month, following the statement. It is further agreed that in the event that I (we) should fail to pay the amount due by the end of the billing cycle following the invoice due date, I (we) shall pay to Stanislaus Farm Supply a FINANCE CHARGE of 1 ½ % per month (an annual percentage rate of 18%) on all past due amounts. Should prepayments or unapplied cash remain on my (our) account, such balances shall act as an offset against the balance of open invoices as it pertains to the calculation of Finance Charges.

I (we) agree that payments may be applied to invoices as remitted by me (us) unless my (our) account is past due. It is further agreed that should my (our) account become past due, all payments on my (our) account shall be applied to Finance Charges, then the remaining payment amount will be applied toward open invoices by aging, oldest to newest.

I (we) agree to pay to Stanislaus Farm Supply any actual costs of collections, including litigation costs and attorney's fees incurred in recovering past due accounts. All agreements and transactions are to be governed by California Law.

I (we) also agree that Stanislaus Farm Supply reserves the right to withdraw credit privileges, discontinue sales, file UCC financing statements without notice, upon default. Any account one hundred twenty (120) days or more past due are in default under this agreement and whereby thereafter my (our) crops and agricultural products where ever located are pledged as security and collateral to Stanislaus Farm Supply under the Uniform Commercial Code (UCC).

I (we) agree to indemnify and hold harmless Stanislaus Farm Supply for damage to equipment or crops resulting from my (our) negligence or misconduct during our dealings together.
